 Club registration invoicing continues to be done in each club account in the Indiana Gotsoccer System. Clubs can view and print their registration invoices directly from the club account.

Risk Management

- <u>Safe Sports Act</u> A federal was passed in February 2018 that makes it mandatory for youth organizations to provide abuse awareness training for all the adult members. The federal law makes it criminal if an adult fails to comply with the federal requirements. Ignorance of the law or abuse awareness is not a defense. Please allow your state association to assist in achieving Safe Sport Act compliance with coaches, administrators, parents etc.
 - MINISTRYSAFE is the web-based program that Indiana Soccer uses to educate parents and guardians about the SafeSports Act (federal law) and what predators look like. This system relies on the clubs to submit a list of guardian names and email address to the state office for upload in the database. Only 3,325 have taken the course of the over 12,000 names that have been loaded. By law, the organization is required to provide the course, it is up to the guardians to take the course.
 - SAFESPORT COURSE Gotsoccer, the USSF and the Center for SafeSports combined
 efforts to make the training/education for coaches and manager specific to their roles
 and it is accessible through their Gotsoccer account. Currently, 4,252 coaches and
 managers have completed the course. Compliance is required for recreation programs
 and your state staff can and will work with all member clubs to implement ways to
 obtain and remain legally compliant.
 - Both systems allow Indiana Soccer to prove that the state association and the participating clubs are compliant with the federal law.
- <u>Background Checks</u> Approximately 5,162 background checks were performed in 2018-2019 for club officers, coaches, team managers and referees.
 - A background check on an individual is valid for two years.
 - Compliance is built into the travel and rec plus side due to checks associated with game rosters etc. The rec side does not have these built-in checks. However, compliance is

equally required. Your state association staff can assist each member club to painlessly obtain and remain compliant. Failure to comply with the required training can be fatal to the athlete and the organization.

- <u>Concussion Awareness and Education</u> Concussion Awareness training is available from the CDC and can be accessed through coach and manager accounts in Gotsoccer.
 - It is mandatory that all coaches and managers take this training.
 - Approximately 1,125 coaches and managers completed this training in 2018-2019. As of the writing of this report, a total 1,822 coaches and managers have completed this training.
 - Indiana Soccer is working with Gotsoccer to set the system to not allow coaches and managers to be assigned to a team until they have completed this course. This works for travel teams.
 - Recreation programs are equally responsible to provide concussion training for coaches and managers. Your state staff stands ready to assist all member clubs in obtaining federal compliance. Please engage with your state staff to develop ways to effectively and efficiently comply with the state and federal mandates.

<u>Insurance</u>

- The state office oversees the administration of the Directors & Officers insurance, liability insurance, and secondary medical insurance coverage for the membership. K&K Insurance currently provides the insurance for both youth and adult programs.
- Your state staff is available to explain the secondary medical insurance coverage and how to access it. Please don't hesitate to ask if you have insurance related questions.

Inclusion in Indiana Soccer's Group Ruling

- Indiana Soccer offers member organizations the opportunity to benefit from the 501(c)3 group ruling held by Indiana Soccer. Members are required to meet minimum standards defined for use of this benefit.
- Currently 16 Indiana Soccer Affiliated and Allied Members receive inclusion in this group ruling.

- To reach more of our members with information about Indiana Soccer, the staff scheduled and hosted four (4) regional meetings in the fall of 2018.
- The meetings were held in Bedford, Warsaw, Greenwood, and Westfield.
- Approximately 15 clubs took advantage of this opportunity.
- While these meetings were meaningful to those that attended, a different approach will be taken for the fall 2019 meetings to better leverage staff resources.
